EPA Portland Making a Visible Difference (MVD) Steering Committee

Coordination, 2015 – Ongoing: MVD is an EPA initiative in 50 cities to coordinate local and federal resources in areas disproportionately impacted by pollution and economic distress. Evan coordinates the Portland MVD Steering Committee's communications, planning, facilitation, and work products. He has developed a matrix of community group focus areas and needs, implemented an MVD survey, developed an MVD factsheet, and coordinated planning for MVD Steering Committee meetings since late 2015.

Seattle Public Utilities (SPU) Wildfire Risk Management Strategy Development,

2015 – 2016: Evan worked with SPU to inform its wildfire risk management strategy for the Cedar River and Tolt Watersheds. He worked with a senior facilitator to inventory all of SPU's wildfire management activities and its wildfire risk factors. He also led 14 external assessment interviews to gather information about the wildfire risk management activities of other land managers to identify opportunities for SPU's wildfire risk management planning.

Seattle Public Utilities North Henderson Combined Sewer Overflow (CSO) Public Outreach, 2014 and Ongoing: Evan leads public outreach for the North Henderson CSO underground storage tank construction project in Seward Park, Seattle. He tracks and coordinates communications between the City and adjacent residents, runs a 24/7 hotline, and assists with outreach material. Additionally, in 2014 Evan shared information with stakeholders through summer tabling sessions in Seward Park.

Bellevue, Kirkland, and Redmond Preemptive and Drop-in Car Wash Outreach, 2014 – 2016: Evan provides spring and fall preemptive outreach to businesses in Bellevue and Kirkland, WA to inventory their points of contact and car wash policies and to inform them about city stormwater regulations. He also developed the Task Force's draft and final recommendations report.

Additional Selected Project Experience

Alaska Statewide Interagency Review Team (SIRT) Assessment, 2016: Evan worked with a Triangle Senior facilitator to facilitate a meeting of the U.S. Army Corps of Engineers-led team that addresses statewide compensatory mitigation and 404 permitting issues in Alaska. Evan interviewed 21 individuals involved in the Alaska SIRT and developed a detailed assessment report that was foundational to Triangle's meeting with the SIRT in April 2016.

U.S. Forest Service (USFS) Listening Sessions for Forest Plan Revisions, 2015: Evan was a primary liaison to the USFS for Triangle's facilitation and stakeholder engagement assistance for the U.S. Institute for Environmental Conflict Resolution and USFS regarding the revision of 19 forest plans in the Northwest Forest Plan (NWFP) area. He coordinated interviews with 36 forest stakeholders in the Pacific Northwest. He simultaneously managed logistics for three public listening sessions that were attended by more than 300 people in March 2015. Evan managed participant comments through transcription of comment cards, forms and flip charts. In June 2015, Evan additionally worked with the USFS to lead a webinar as part of a large public meeting in which subject matter experts presented 20 years of forest monitoring data in the NWFP area.

National Park Service (NPS) Sustainable Outdoor Lighting Workshop, 2015 and 2016: Evan worked closely with a Triangle Senior Facilitator to plan a workshop hosted by the NPS in Fort Collins, CO. The workshop trained NPS staff in the use of recent developments in LED or other lighting technologies that address NPS concerns including energy efficiency, costs, public safety, and natural and cultural resource protection. Evan was integral to development of the meeting agenda, coordinated presentations, assisted with workshop technology and notetaking, and developed a detailed workshop summary. He later developed a booklet that captures key workshop outcomes.

Evan supported the facilitation of 17 committee meetings and more than twenty planning meetings with King County Staff between August 2013 and October 2014. Triangle's efforts led the committees to identify twenty-nine policy and financial options for the E-911 Program Office to consider for ensuring the future efficiency and effectiveness of King County's 911 system.
