WA State Housing Affordability Response Team, 2017

SOPHIE'S EXPERIENCE, CONTINUED

Lower Duwamish Waterway Superfund Cleanup, 2015 - Ongoing

- Facilitates quarterly meetings with tribes, trustees, and community groups (TTC) to discuss progress and concerns regarding the cleanup of the Lower Duwamish Waterway.
- Facilitates semiannual stakeholder meetings that provide technical information to over 100 participants.
- Convenes the Healthy Seafood Consumption Consortium, which brings together members of the fishing community with federal, state, and local government agencies.
- Supports the formation of the Lower Duwamish Waterway Roundtable that will bring together a broad range of participants from governmental, Tribal, business, and community sectors to provide recommendations to EPA on the cleanup of the Lower Duwamish Waterway.
- Engaged over 60 community members through inclusive public outreach events at cafes, food trucks, and libraries, to get public input on the Community Involvement Plan.

Coal Creek Flood Reduction, 2015 - Ongoing

- Developed a Public Involvement Plan for the City of Bellevue to conduct public outreach and education for a flood reduction project in the Newport Shores neighborhood.
- Maintains the project website and writes quarterly articles for a neighborhood newsletter.
- Organizes public open houses and neighborhood meetings to inform and solicit feedback from Newport Shores residents about this flood hazard reduction project.
- Designs visually engaging postcards and flyers to keep residents updated on this project.

Port Hadlock Sewer Website, 2016

- Led the development and design of the <u>Port Hadlock sewer project website</u> in Jefferson County.
- Interviewed staff to develop clear language and intuitive architecture.

West Central Local Integrating Organization (LIO), 2014 – 2015:
