Lower Duwamish Waterway Cleanup, 2015 - Ongoing

- Facilitates quarterly meetings with tribes, trustees, and community groups (TTC) to discuss progress and concerns regarding the cleanup of the Lower Duwamish Waterway.
- Organizes semiannual stakeholder meetings that provide technical information to over 100 participants.
- Facilitates an "Organizing Committee" to shape the future of a "Roundtable" that will provide feedback to the Environmental Protection Agency regarding the cleanup of the Lower Duwamish Waterway.
- Interviewed over 75 individuals from city, state, and federal agencies; tribal nations; and nonprofit organizations to develop a "Community Involvement Plan" for the Lower Duwamish Waterway cleanup.

- Coordinated interpretation services at outreach sessions and translation services for the Community Involvement Plan.

City of Seattle Industrial Lands Advisory Committee, 2016 – ongoing

Kitsap Regional Coordinating Council (KRCC), 2015 - Ongoing

- Supports the work of KRCC in developing shared land use and transportation policies across Kitsap County.
- Coordinates the KRCC Executive Board, which consists of elected officials, tribal leaders, the US Navy, and transit agencies.
